Mayor LaPorte called the meeting to order at 7:30 p.m., following roll call, he then opened with the Pledge of Allegiance.

A motion was made by Mr. Hegedus to approve the 1st amended agenda and supported by Mr. La Fever. The minutes from August 22, 2017, regular meeting were approved as printed, motioned by Mr. Hegedus and supported by Mr. Wittman. All ayes, both motions were carried.

PUBLIC COMMENTS, CORRESPONDENCE, EVENTS, PRESENTATIONS:

- National/State Main Street Conference, September 20 and 21, 2017 – Julie Kreilick reminded the Council of the Main Street Conference and requested that they attend the meetings if at all possible. There will be a new strategy presented for the next 3 – 5 years game plan. A schedule was given to the Council with the agenda of the conference.
- Community Survey Report – Williams and Works has provided a written report from the data that was collected during the recent open house.
- Marlene Frontiera addressed the Council in regards to noisy dogs and feral cats in her neighborhood. The Council advised that in regards to the cats, there is not much that can be done as there are no ordinances in effect for this issue. Oceana County Animal Control will not deal with feral/stray cats. There is no quick answer to take care of this situation. Mr. Wittman suggested that she contact local vets to see if they know of facilities that will take them if she can “live” trap them. The noisy dog issue has to be addressed by the Police Department.

 - Good fair week, reports of missing kids, lost/stolen property, assault.
 - Aug. 30, an ALICE refresher course was held for the Hart Public School staff.

RENEWABLE ENERGY PURCHASE AUTHORIZATION

WHEREAS, the City of Hart owns and operates a hydroelectric generation and electric distribution system;
and

WHEREAS, Hart Hydro-Electric purchases its electric energy and capacity from the Michigan Public Power Agency (MPPA); and on August 9, 2017 the MPPA Board of Directors approved a 20-year power purchase commitment (PPC) from the proposed 'Pegasus Wind' energy project in Tuscola County, Michigan replacing the abandoned 'Huron Wind' project in Huron County, Michigan; and

WHEREAS, the MPPA Energy Services Manager recommends a renewable energy purchase for Hart Hydro-Electric for a 2.32% share (about 1.4 MW) of an approximately 61 MW wind energy project; and

WHEREAS, on September 11, 2017, the Hart Power Board recommended this purchase authorization to Hart City Council; and

WHEREAS, in order to secure the benefits of efficient self-government and to promote and protect our common interests and welfare, the City Council hereby declares:

NOW THEREFORE BE IT RESOLVED THAT THE CITY COUNCIL:

Accepts and approves the August 9, 2017, MPPA and September 11, 2017, Hart Power Board recommendations to acquire renewable wind energy from the MPPA as follows:

<i>Term</i>	<i>Project Share</i>
<i>20 Year PPC</i>	<i>2.32%</i>

Authorizes and directs the City Manager to sign the August 7, 2017, letter of authorization on behalf of Hart City.

Mr. Rickard reported on:

- Creeks Sub-Division: The City is now the owner of this sub-division, moving forward the City needs to decide how to proceed and develop the project. There are 62 units within the property boundaries that are available. There is a location in Kansas that gave away the lots to new residents. The City may need outside services to assist in the development of this land. This will be discussed further in future meetings.
- City Council Compensation: A spreadsheet was presented to the Council showing the potential cost of increases for Council and payments to residents who participate on a board/commission/committee. Mayor LaPorte stated that this was discussed at the Finance meeting before the Council meeting and he asked the council to use the spreadsheet as a worksheet for their input, and it will be further discussed at the next session.

COMMUNICATIONS FROM THE MAYOR AND COUNCIL:

- Mayor LaPorte asked what could be done about the cattails growing along the lake, Mr. Rickard stated that the City could spray them without interference from the State. He will be addressing this issue. Mayor LaPorte also suggested that the bamboo be treated again.
- Mr. Wittman asked that the docks at John Gurney Park need to be addressed and repaired/replaced. Mayor LaPorte has talked to the Freed's, and they will be taking care of this issue.
- Mr. Wittman asked who owns the property across from the fair grounds by the State Farm office. This was used for paid parking during the week of the fair. He wants to know what the City did about this; he was told that the man did not come to City Hall for a permit and that the area was zoned B2 and could be used for parking as long as the landowner gave permission.
- Mr. Frontiera brought up how nice the area was looking behind Dale & Gail's business. He brought up how bad the pole building was looking behind this area and how it was a safety hazard, and it was suggested to him that the City buy this building and remove it. This suggestion has already been made to the City, and it will also be discussed by TIFA at their next meeting, it is worth exploring further.
